What is this product?

Type

Obiectives

WisdomTree Physical Gold - EUR Daily Hedged is a UCITS Eligible Exchange Traded Commodity (ETC) designed to offer security holders a simple, cost-efficient and secure way to access Physical Gold currency hedged by tracking the MS Long Gold Euro Hedged Index. The product enables investors to gain exposure to the movement of Physical Gold spot price, less the applicable management fee, with a daily currency hedge against exchange rate movements. WisdomTree Physical Gold - EUR Daily Hedged is backed by physical, allocated Physical Gold held by JPMorgan Chase Bank, N. A. (the custodian). Only metal that conforms with the London Bullion Market Association's (LBMA) rules for Good Delivery can be accepted by the custodian. Each physical bar is segregated, individually identified and allocated. For example, if the MS Long Gold Euro Hedged Index rises by 1% over a day, then the ETC will rise by 1%, excluding fees. However if the MS Long Gold Euro Hedged Index falls by 1% over a day, then the ETC will fall by 1%, excluding fees.

You may trade this product on various stock exchanges at your own discretion.

Intended Retail Investor

Term

The unfavourable scenario for where you exit after the recommended holding period occurred to the WisdomTree Physical Gold - EUR Daily Hedged between 18/05/2015 and 16/03/2020. The moderate scenario for where you exit after the recommended holding period occurred to the WisdomTree Physical Gold - EUR Daily Hedged between 22/05/2018 and 21/03/2023. The favourable scenario for where you exit after the recommended holding period occurred to the WisdomTree Physical Gold - EUR Daily Hedged between 23/12/2019 and 21/10/2024. Where the period of time between the dates is less than the recommended holding period the performance has been extrapolated by linear transformation to the recommended holding period.
