What is this product?

Type: Shares of a Sub-Fund of MULTI UNITS LUXEMBOURG, a SICAV.

Term: The term of the Sub-Fund is unlimited. The Management Company may terminate the fund by liquidation or merger with another fund in accordance with legal requirements.

Objectives: The Fund is an index-tracking UCITS passively managed. The investment objective of the Fund is to track both the upward and the downward evolution of the S&P 500 ® 2X Inverse Daily Index ("Benchmark Index"), denominated in US dollars (USD) in order to offer an inverse exposure to with daily 2x leverage, to the performance of the United States equity market while minimising the volatility of the difference between the return of the Fund and the return of the Index (the "Tracking Error"). The anticipated level of Tracking Error in normal market conditions is indicated in the prospectus. The Benchmark Index is a net total return index. A net total return index calculates the performance of the index constituents on the basis that any dividends or distributions are included in the index returns after withholding tax retention. The Benchmark Index provides two times the inverse performance of the "S&P 500 ® Index" (the "Parent Index") and represents a short position in this Parent Index. Over one business day, investors will be exposed to the double of the inverse of the evolution of the level of the Parent Index, and an increase of the level of the Parent Index will result in a greater decrease in the Net Asset Value of the Fund that day. On the contrary, for investment periods greater than one business day, the performance of the fund will not be the double of the inverse of the performance of the Parent Index, and could even be in the same direction. The website <https://us.spindices.com/> contains more detailed information about the Benchmark Index. The Fund seeks to achieve its objective via indirect replication by entering into an over-the-

counter swap contract (financial derivative instrument, the FDI"). The Fund may also invest in a diversified portfolio of international equities, whose performance will be exchanged against the performance of the benchmark Index via the FDI. Updated composition of the Fund holdings is available on www.lyxoretf.com. In addition, the indicative net asset value is published on the Reuters and Bloomberg pages of the Fund, and might also be mentioned on the websites of the stock exchanges where the Fund is listed. The Fund is eligible to the French Equity Saving Scheme (PEA), and as consequence, a minimum of 75% of the Fund assets are invested in diversified equities issued in the European Union.

Intended Retail Investor: This product is intended for investors, with an average knowledge of and some experience of investing in funds, and who are prepared to take on a high level of risk to their original capital.

Redemption and Dealing: Shares may be sold (redeemed) as stated in the prospectus at the respective dealing price (net asset value). Further details are provided in the MULTI UNITS LUXEMBOURG prospectus.

As this is a non-distributing share class, investment income is reinvested. the accumulation share automatically retains, and re-invests, all attributable income within the Sub-Fund; thereby accumulating value in the price of the accumulation shares.

What happens if Amundi Asset Management is unable to pay out?

What are the costs?

Recommended holding period: 1 day is based on our assessment of the risk and reward characteristics and costs of the Sub-Fund.

This product is designed for short-term investment; you should be prepared to stay invested for at least 0.00273 years. You can redeem your investment at any time, or hold the investment longer.

Order Schedule: Orders to buy and/or sell (redeem) shares received and accepted by 06:30 PM on any Luxembourg business day are ordinarily processed on the same day (using the valuation of that day).
